Dear Sirs:

Thank you for your letter of November 6, 1992. While we appreciate your considering meeting our demands, we must insist on your immediate agreement to change the color of the book cover, delete AAWS' name and trademarks and change your name. Included in that agreement should be the new color, a proposed book jacket, the new name of the publisher and a mock-up of the new inside covers of the book.

Our reference to Section 43(a) of the Lanham Act is not a "miscommunication." That statute is the law which provides a remedy for the type of unfair competition, the likelihood of confusion, you have apparently intentionally created through publication of the soft cover third edition of the Big Book. You may want to consult an attorney who specializes in trademark and unfair competition law.

Please note that I am not addressing "carrying the message"; I am writing about a clear violation of the federal unfair competition statute, as interpreted and applied by federal courts.
