Dear gentle persons:

Your letter of October 20, 1994 addressed to the Trustees of the General Service Board has been referred to A.A.W.S., Inc as publishers of AA literature and holders of copyrights on the literature.

As we have previously informed you, AAWS has been entrusted with the ownership of copyrights on all Bill's writings and on all Conference-approved literature. With that trust, AAWS has the corresponding obligation to protect its ownership rights, and must do so. We, therefore, appreciate your assurances that, for now, your books will:

- o not be sold in Canada
- o have no reference to ALCOHOLICS ANONYMOUS on the cover
- o include a disclaimer stating: "Publication of this book does not imply endorsement by or affiliation with the General Service Office."

However with respect to the disclaimer, we ask that you use the following language rather than the language you propose.

"I.W.S., Inc. is not affiliated with Alcoholics Anonymous World Services, Inc. or with the General Service Office of Alcoholics Anonymous. The publication of this book was not authorized or endorsed by Alcoholics Anonymous World Services, Inc. or the General Service Office of Alcoholics Anonymous. Accordingly, the publication of this book does not imply authorization or endorsement by, or affiliation with, Alcoholics Anonymous World Services, Inc. or the General Service Office of Alcoholics Anonymous."

Although the copyright of the first edition of the book ALCOHOLICS ANONYMOUS has expired, our Spanish translation of that

book has been copyrighted and is protected under copyright law. We advised you of the copyright of our Spanish translation, and that your publication clearly was an infringement of our copyright. We again request that you agree to discontinue further sale of this publication, and that you assure us in writing that you have done so.

We agree to meet with representatives of I.W.S., Inc. to discuss resolution of issues concerning your publications as they affect the rights of Alcoholics Anonymous World Services, Inc. Please give me a call as soon as possible so that we can discuss the details of where and when we can meet.

In agreeing to meet with you, Alcoholics Anonymous World Services, Inc. reserves the right to take all legal actions that may be necessary to protect its interests.
